## Great Lakes Iron Ore Trade Little Changed in November

CLEVELAND – Shipments of iron ore on the Great Lakes totaled 5.1 million tons in November, a decrease of one load in a 1,000-foot-long U.S.-flag laker. However, shipments did outpace the month's 5-year average by nearly 4 percent.

Year-to-date the iron ore trade stands at 49.8 million tons, a decrease of 1.7 percent compared to the same point in 2017. The shortfall has been decreasing over the course of the shipping season. At the end of April, iron ore shipments were down nearly 14 percent.

Through November iron ore loadings are 6.9 percent ahead of their 5-year average for that timeframe.

In turn, those cargos create and sustain nearly 116,000 jobs in the eight Great Lakes states and generate more than \$20 billion in economic activity, \$8.3 billion in personal income, \$16.4 billion in business revenue, \$4.1 billion in local purchases and \$3.7 billion in taxes.
